This project provided operational support for tidal wetlands management technical support provided by the Center for Coastal Resources Management Wetlands Program staff. The Wetlands Program personnel provided routine advisories and impact assessment preparation; maintenance of a permit database and website; and assisted in publication of newsletters and the supporting materials for the outreach education offerings. Technical advisory activities encompassed everything from verbal communications to written environmental assessments. Five computer-based elements: GPS, digital photography, Sybase, word processing and ArcView/ArcInfo are required in order to produce the electronic permit review reports. A database is maintained by program staff who enter detailed information on all projects impacting Virginia's marine resources. Interactive access to the database, as well as the permit review reports, the original joint permit applications, and all related additional information and photos are available on the CCRM website which is updated regularly. CCRM now produces two biannual newsletters – the updated *Virginia Wetlands Report* and the new *Rivers & Coast*. The *Virginia Wetlands Report* continues to inform readers of near-shore environmental science and related issues in an effort to influence better tidal shoreline decisions, and in addition to a new look, now serves to announce upcoming workshops and educational opportunities, both inside and outside of VIMS. The *Rivers & Coast* newsletter is designed to keep readers well informed of current scientific understanding behind key environmental issues as they apply to watershed rivers and coastal ecosystems of the Chesapeake Bay. The newsletter is written for three perspectives – the general public, managers or decision-makers, and legislators – and provides information that goes from the big picture down to local relevance. Both newsletters were mailed to over 1800 individuals, including all local wetlands board members, local and state agency personnel, General Assembly members, and interested private citizens. In addition to being distributed for free and available to any interested subscriber, they are available online. The Wetlands Program was also responsible for organizing and hosting a Tidal Wetlands Workshop, held on March 10th, 2006, on the College of William and Mary's main campus. 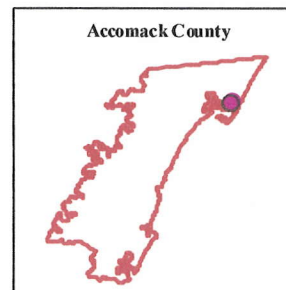

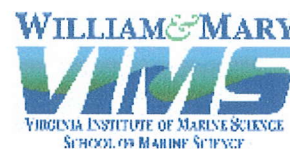

NOTE

The Virginia Institute of Marine Science (VIMS) recognizes that the regulatory process considers all aspects of a particular project, including socioeconomic factors. This report, however, only addresses marine environmental concerns.

Findings & Recommendations:

We have reviewed the application from the perspective of the marine environment and have determined that portions of the proposed project warrant careful consideration. Project impacts as well as alternatives to reduce those impacts are discussed below.

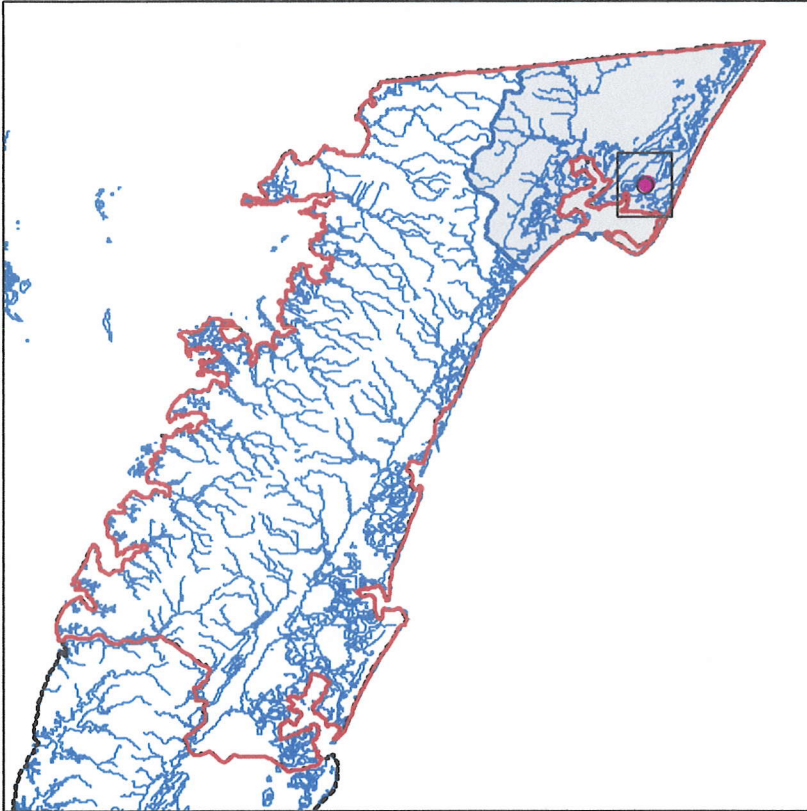
Based on the limited information available in the application, we have determined that the U.S. Fish and Wildlife Service proposes to dredge 435 cubic yards of material from 1,307 square feet of subaqueous bottom and install a boat ramp measuring approximately 960 square feet. In addition, the applicant proposes approximately 660 square feet of service pier structures and the installation of approximately 400 square feet of riprap at the landward edge of the proposed boat ramp. The proposed project will impact approximately 200 square feet of vegetated wetlands, 240 square feet of non-vegetated wetlands, and approximately 2,687 square feet of subaqueous bottom. During a site visit conducted on October 31, 2005, an existing boat ramp was observed directly adjacent to the proposed location of the new ramp. Based on what can be determined from the limited amount of information in the application, the proposed boat ramp is to be located on the site of an existing boat basin. It is unclear why the site of the existing boat ramp is not being considered for construction of the new facility. In addition, it appears from the application that the dredge disposal area may be sited in wetlands.

We would recommend that the applicant consider utilizing the location of the existing boat ramp for the proposed facility. This alternative may greatly reduce the amount of dredging required. In addition, we would recommend that any dredge material be disposed of only on upland areas. We would also suggest that the pouring of wet concrete directly into wetlands, as observed on the landward side of the boat basin, is undesirable from a marine environmental perspective.

We did not review the improvements to the bike trail and bridge as they will not result in impacts to tidal resources. These areas have been impounded for waterfowl management and severed from tidal influence through the use of water control structures.

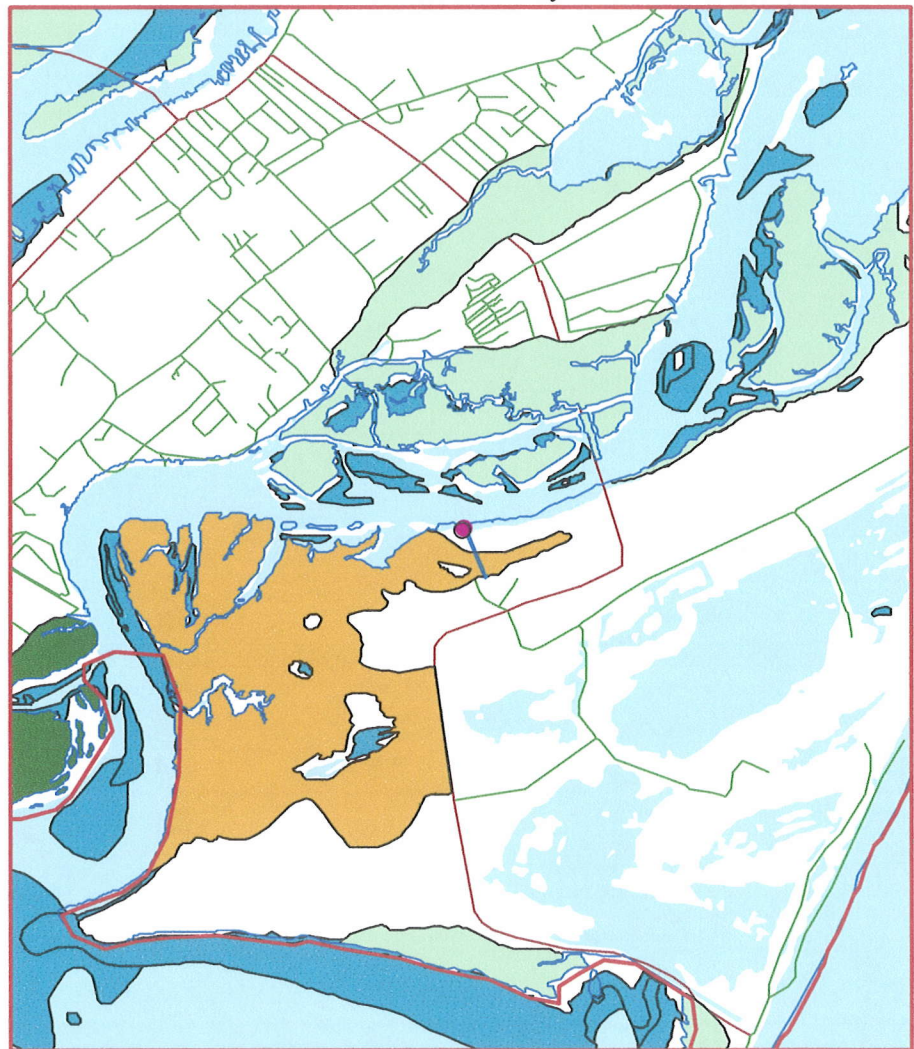
