This project provided operational support for tidal wetlands management technical support provided by the Center for Coastal Resources Management Wetlands Program staff. The Wetlands Program personnel provided routine advisories and impact assessment preparation; maintenance of a permit database and website; and assisted in publication of newsletters and the supporting materials for the outreach education offerings. In June, CCRM launched a new version of our website including drop-down navigation buttons, side menus on all subpages for easier use, as well as the “Coastal Zone” and “Highlights” sections on the main page to keep the website users up-to-date on the latest CCRM projects and information. The site will continue to evolve and improve. Technical advisory activities encompassed everything from verbal communications to written environmental assessments. Five computer-based elements: GPS, digital photography, Sybase, word processing and ArcView/ArcInfo are required in order to produce the electronic permit review reports. A database is maintained by program staff who enter detailed information on all projects impacting Virginia’s marine resources. Interactive access to the database, as well as the permit review reports, the original joint permit applications, and all related additional information and photos are available on the CCRM website which is updated regularly. CCRM produces two biannual newsletters – the *Virginia Wetlands Report* and *Rivers & Coast*. The *Virginia Wetlands Report* continues to inform readers of near-shore environmental science and related issues in an effort to influence better tidal shoreline decisions, and now serves to announce upcoming workshops and educational opportunities, both inside and outside of VIMS. The *Rivers & Coast* newsletter is designed to keep readers well informed of current scientific understanding behind key environmental issues as they apply to watershed rivers and coastal ecosystems of the Chesapeake Bay. Both newsletters were mailed to approximately 2000 individuals, including all local wetlands board members, local and state agency personnel, General Assembly members, and interested private citizens. In addition to being distributed for free and available to any interested subscriber, they are available online. The Wetlands Program was also responsible for organizing and hosting three workshops. The Tidal Wetlands Workshop was held on the VIMS campus on October 19th, 2007. Two “On the Road” trainings concentrating on Integrated Shoreline Management for local government staff were held locally for the Middle Peninsula on April 28<sup>th</sup>, 2008 and Smithfield Regional on May 28<sup>th</sup>, 2008. 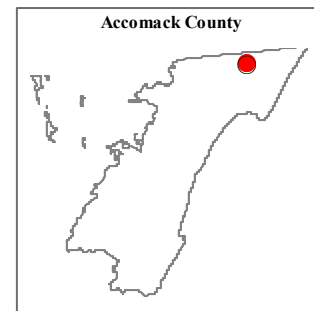

# VIMS Shoreline Permit Application Report # 08-0399

## NOTE

The Virginia Institute of Marine Science (VIMS) applies an integrated coastal management perspective during the review of proposed activities on tidal shorelines. The coastal ecosystem has dynamic connections between wetlands, coastal waters and the surrounding landscape. This provides valuable ecosystem services, such as maintaining water quality, shoreline stability, and wildlife habitat. Activities should be designed to avoid adverse impacts to coastal resources. When impacts are unavoidable, every effort should be made to minimize impacts and provide compensation as required.

## Findings & Recommendations:

5/21/2008 Revised

The proposed free-standing bulkhead was increased to extend along the entire length of the proposed pier, as well as the 90-foot T-head. The stated purpose is to minimize sediment accretion in the proposed slips, where the water depth is already less than 4 ft below the mean low water elevation.

If the pier cannot be moved further out away from the marsh edge, then the desire for some type of retaining structure is understandable. However, attaching a low bulkhead to the pier is an unconventional approach. It is difficult to predict how it will affect physical and biological factors that influence the adjacent tidal marsh.

A marsh toe revetment placed along the marsh edge is the preferred structure because it would have less effect on tidal exchange and marsh access for fish and crabs. A low bulkhead at the marsh edge is another alternative, although less desirable due to the effects of reflected boat wakes and waves. The proposed bulkhead attached to the pier should be considered only if these preferred options for marsh edge stabilization are not feasible.

It is assumed that the bulkhead will adversely interfere with tidal flushing if it extends 600 feet along the length of the pier, plus 90 feet at the T-head, with a height 1 foot above mean high water. Instead of a sheetflow pattern of inundation and receding tides, more channelized flows are expected around the bulkhead ends, between the marsh edge and bulkhead and occasionally over the top of the wall. Scouring along the marsh edge and bulkhead may occur as a result.

The landward extent of tidal inundation might be affected, which may lead to changes in the vegetation community and possibly increased invasion of *Phragmites* if regular high tides no longer reach the existing bank toe. The proposed length and height will also create a long barrier for aquatic organism movement into and out of the marsh.

A bulkhead height as close as possible to the marsh surface is advised to reduce the potential for these adverse effects. A cross-section that shows the marsh surface, marsh edge, bulkhead and pier all in relation to the mean high and low water elevations would clarify the horizontal and vertical relationship between these features.

Other environmental concerns previously mentioned for the proposed marina still remain.

## VIMS Shoreline Permit Application Report # 08-0399

4/12/2008 Original

The Captain's Cove Golf and Yacht Club proposes a new community marina pier with 46 mooring slips in a dredged canal off Chincoteague Bay. There is an extensive tidal marsh between the proposed pier and the upland area of the marina.

The proposed improvements include a 130-foot access pier to cross the existing marsh, a main pier and a T-head pier. The proposed mooring slips include an equal number of 20-foot and 30-foot slips (23 each), 23 finger piers and 69 freestanding pilings. No fueling or pump-out facilities are included with the project.

The potential environmental impacts associated with marinas include shading effects from piers and other structures plus increased shoreline erosion and wildlife disturbance due to boat traffic. Water quality impacts depend on the capacity of the waterway to assimilate pollutants, such as petroleum products, toxicants, bacteria, and solid waste.

There are permit records for 60 existing slips on the west side of the new yacht club building (VMRC #01-1454). There should be a demonstrated need for the proposed number of new mooring slips. Adequate sanitary facilities should be provided for the entire marina (106 slips), as required by the Sanitary Regulations for Marinas and Boat Moorings and the State Health Department. There should be no overnight occupancy of boats unless authorized by these regulations.

A marina management plan is advised if one does not already exist. This plan would provide regulatory requirements and guidance to the marina operators and users for fuel and oil spill response, the location of the closest pump-out facilities, storm preparations, proper handling of fish waste and solid waste, and boat cleaning. Additional information about voluntary pollution reduction measures is available from the Virginia Clean Marina program web site ([www.virginiacleanmarina.com](http://www.virginiacleanmarina.com)).

A 90-foot freestanding bulkhead is also proposed at the T-head pier to serve as a breakwater due to wave action from Chincoteague Bay. Breakwaters should be designed so they do not create adverse sediment transport patterns or unduly disturb marine resources. They should also be designed to not fail under wind, current and tide conditions normally experienced at the site.
